On 2/3/14 at 2:53 pm, I Ofc. Arthur (UNIT 3503) responded to the Atlanta Boxing Gym at 1135 Spring St NW in regards to a fight.

When I arrived on scene I met the victim Mr. Jason Gervals (678-663-7172).Mr. Gervals stated that he went to the Atlanta Boxing Gym located at 1135 Spring St for a business meeting at 2:00 pm. He arrived around 2:30 pm to meet Joey Degratis but when he walked into the back office he was hit from behind, knocking him to the ground. While on the ground he stated he kept getting hit and kicked. 1 White male and 2 black participated in the assault according to Mr. Gervals. The white guy then asked if the victim knew who he was and Mr. Gervals stated that he did not know who he was. The white male then advised his name was Michael Morrison and that he should leave Kalen Russell alone. Kalen Russell is the Girlfriend of Mr. Gervais. Then the white male struck him again and advised that if he called the police he would kill him and his family. After making the threats he forced the victim to sign and fingerprint a statement that said they were boxing. The white male then took his wallet and made sure that the signature was identical to the one that was on the paper that was signed. After that exchange the suspect made the victim to put some boxing gloves on and then took pictures of the victim waring the gloves. The victim then walked out of the gym and called police.

The victim was treated by Grady Unit 757. They advised that the only visible injury was some swelling in the left cheek and a small busted mark on his lip. The victim claimed that he had some scratched on his chest but no visible blood.

When I began to do the report the victim advised that he was involved in some on going police issues and when he was checked by the Atlanta Crime Information Center he showed to have an active warrant from Dekalb County-------. Once he was taken into custody he asked if the passenger in his car could make a phone call for him. Untill this point is was unknown that the car had any other passengers due to the black out tinting on the car. I then approached the car and found a white female hiding in the back seat. She did not let her presence be known and as I knocked on the window of the car she was reluctant to open the door. I then asked the female for her identification and she stated that she did not have ID.

The female was identified as Kalen Russell (3/9/92) and she was checked by the Atlanta Crime Information and also showed to have a active Dekalb County Warrant WNO 11srt 567d / DOW 1/27/14. She was then taken into custody on the warrant. Search incident to arrest Ofc. Sauls located an ID card in her possesion in the name of Kalen Russell.

Mr. Gervals then asked if he could have his friend pick up his car (GA TAG CBI5122) and Ruger 9mm pistol. James Michael Gray (7/19/79) (678-570-8796) then took possession of the car but the firearm was turned into police property for safe keeping.

Both Arestees were transported to the Fulton County Jall.
