On 01/12/2014 at approximately 0128 hours, I responded to 1767 Buckhead Lane in reference to a domestic dispute.

While en-route, I was advised that the female involved. (Kalen Joi Russell) had left the location of foot. She was described as wearing all black clothing and headed toward the area of Shady Valley Drive. When I arrived on Shady Valley Drive I located Russell walking up the road. I got out with her at the intersection of Shady Valley and Lenox View.

When I saw her she was walking and doing so with no problems. I asked her if she was okay and she began crying and stated that her ex boyfriend (Jason Gervais) had assaulted her. She had some slight abrasions that appeared to start just below her right clavicle and ended just above it. She stated that this was done by Gervais. However, the abrasion was clearly not marks made by fingernails.

(Russell also complained of having injuries to her left ankle and left side. She initially requested EMS but then later denied medical attention and asked to be transported to an address off 1449 Woodland Hills, Atlanta, GA.)

I placed Russell in the rear of my patrol car and transported her back to 1767 Buckhead Lane. My camera was activated during this time.

When I arrived at 1767 Buckhead Lane, I made contact with Jason Gervais. He began to tall me that there was a TPO on Russell. Upon both Gervais and Russell, I did not see any indication that a TPO was active. In speaking with Gervais further I determined that the judge had issued a stay away as a condition of Russell's bond. Gervais began to tell me that Russell had struck him in the face. However, there were no marks on his person to collaborate this. He explained to me that Russell had jumped off of his third story deck. Gervais proceeded to show me a video where he was candidly speaking with Russell in his laundry room after this incident. He was asking her why she jumped off of the deck and she stated that she was "trying to get her lighter." I questioned her about this later and she stated that she climbed down the balcony. The abrasion on Russell's person was more consistent with this type of injury.

Gervais said that Russell jumped off and landed in the mud. He then allowed her to go back into his residence and take a shower and clean her clothes. The video he showed me was taken after Russell had showered.

After taking Russell to 1449 Woodland Hills, I reviewed the video of her in the rear seat of my patrol car. In doing so. I saw that she began choking herself when she was left alone in the car. It was apparent that Russell was attempting to cause injury to herself. This incident occurred at 01:41 according to the clock on my in car camera. Russell held her hand to her neck for approximately 10 seconds.

There were no charges due to lack of evidence and the fact that Russell's injuries were self sustained.
